Report

During 2022 and into 2023, the Foundation has supported the operational needs of the Fort Nisqually Living History Museum (FNLHM) while focusing on board recruitment and preparing for the upcoming capital campaign.

The Foundation has continued to fund school tour scholarships to ensure all students have access to the Museum. In 2023, this funding returned to pre-COVID levels. The Foundation has taken on the essential role of operating the bar for Museum events that require liquor sales. The Foundation also provided bookkeeping support to the Museum when it hosted the 2022 National ALHFAM conference. The Museum has requested less operating support for other activities than in years past. This has enabled the Foundation to build its cash reserves for upcoming capital projects, as well as for emergency funding -- as was needed during COVID 19.

Two new members joined the board of the Foundation this past year. Amand McGinn has a background in marketing, communications and tech. She's interested in preserving the diverse history and experiences the fort offers. She is also interested in preserving local Indigenous culture and is a member of the Cowlitz Indian Tribe. Lawrence Bradley is a long-time Fort volunteer, known for his alter-ego Thornhill and skill in the Fort's kitchen, and brings a passion for the Fort and its volunteers.

Plans for the capital campaign are still in their infancy. We know we will be fundraising for construction work related to the stabilization and restoration of The Sale Shop and The Kitchen, and possibly also The Wash House. Fundraising goals are pending a design plan and budget for the construction work. We expect funds will include cash on hand, grants, and individual donations. In preparation for fundraising activities, the Foundation has increased the Foundation's presence at Fort events, held awareness-building events such as the Porch Party, and met with potential partners and consultants.
